#### **4-H Livestock**

The Livestock Superintendents of each species and I held a discussion yesterday July 1<sup>st</sup> about the Vesicular Stomatitis Virus (VS). This is a highly contagious disease and can affect cattle, horses, sheep, goats and swine. After discussion with local veterinarians about the disease and how it is spread (nose to nose and flies) I also learned that there are active cases in Butler, Cowley, Greenwood and Sumner Counties. THE DECISION HAS BEEN MADE, THAT ALL LIVESTOCK WILL COME IN THE DAY OF SHOW AND GO HOME THE SAME DAY. THIS INCLUDES POULTRY AS WELL.

Also WILCO Vet clinic has offered to do a certificate of veterinary inspection free of charge when animals arrive, you will need to contact them about a time. This will work for the health certificate.

I know this is not what any of us want, but we feel this is the best decision we can make to protect the livestock and the livelihood of a lot of people. The awesome members of Wilson County had to do this same thing in 2007 after the big flood. It turned out to be a great fair.

Livestock can be brought in 1 and ½ hours before the show. And should be taken home as soon as possible. I know some of you will have both bucket calves and sheep/goats we would ask that you please leave animals not showing at the time in the trailer. It will be the same on Saturday if you need to bring both hogs and beef leave the cattle at the trailer. For the Premium Sale, Kim Smith offered to put together photos of each member with their animal to use at the sale (this is what we did in 2007) along with the member in the ring. Round Robin showmanship is still being discussed. I have also contacted Dale Lanham who generally puts based bid on the sheep and goats to see what we can work out for those.

Please know that this decision has not been made lightly, we know some of you have a long drive and we are sorry for that, but felt it is the best decision we could make.

Please be prompt. Remember BE EARLY - You need to be in the building 20 minutes before your first scheduled judging consultation. Be sure to check in at the door and pick up your exhibit cards. The schedule will sometimes run ahead. Ribbon placings may be dropped at the judge's discretion due to lateness. Judges will not be asked to stay over 15 minutes past their last scheduled judging consultation for the day. Schedules

will be worked around if possible in the event of a conflict. If you are entered in more than 5 classes per level <u>remember you can only bring 5 exhibits</u>, one per class.

If you are unable to attend the conference judging, but can have your food there, it can still be judged. You may have someone else bring your food for judging, but no one can accompany your exhibit to be judged. Please make any notes you want the judge to know about your food and attach it to your exhibit. 4-H Foods Judging will only take place on the 17<sup>th</sup>.

\*\*\*\*New this year! Each club will have a table to display their members food items. Each member that has a non-perishable food item should display at least one item on the table. All perishable items and other non-perishables will need a picture and a recipe to be compiled in a notebook on the table as a collection. Tables may be decorated and they will be judged by people's choice.

## 4-H RECORD BOOK DO'S & DON'TS

As we approach the Fair the farthest thing from our minds is record books, but that should be the first thing you think about.

As we are busy cooking, sewing, cutting and pasting that craft project, and washing the pigs, take pictures. Action pictures of you doing the work are wonderful for your record book. Pictures in the show ring are nice, but most judges want to see you doing the hard part. I hope everyone has kept track of the hours spent working on those projects. An important part of your records is knowing how much time

you spent in the kitchen or in the pen feeding. Remember 4-H records don't have to be hard. If I can be of help to you as you fill out your records, please give me a call.

#### Record Books and Kansas Awards Portfolio

At Achievement Banquet we will be giving Awards in three age groups, Junior (Age 7-9), Intermediate (Age 10-13) and Senior (Age 14-19) as of January 1, 2020 in each awards area.

The younger group will complete Record books as usual. The older group will complete the Kansas Awards Portfolio (which includes part of your record book) in order to compete for county Awards. Copies and instructions for the KAP (Kansas Awards Portfolio are in the office). This Award Application is what has to be filled out to go on to compete for Area and State Awards.

The Community Leaders or Parents Committee of your club will set the date that Record Books (age 7-13) and Kansas Awards Portfolio (age 14-18) are due. Please meet your club's deadline, as Leaders and Parent's Committee's must review the Record Books and make nominations for awards before they are turned in to the office.

If you need any help or information with Record Books or the Kansas Awards Portfolio, please let us know.

If the Senior 4-H'ers have filled out a KAP in an area they do not have to be nominated by the Community Leaders. The KAP is automatically eligible to compete for county awards so, seniors fill out KAP's in as many areas as you want to compete in for awards. But, remember you have to have a complete KAP for each award area including copies of your permanent record and personal page (we can help you with copies).
